# June 25-27 National Conference on Problem Gambling at Indianapolis

**Planning continues for the 23rd** annual National Conference on **Problem Gambling which will be** held at the Hyatt Regency Indianapolis June 26-27. This conference is the largest gambling conference in the country and generally attracts 500 attendees. The theme for the conference is: "Together, we make a difference." The success that the Indiana Council has experienced is directly due to our efforts at bringing all of the Indiana problem gambling stakeholders together on our large board and advisory group. This philosophy is also evident in the development of our regional seven NCPG affiliate group, the **Midcental Alliance on Problem** Gambling, whose members were active in planning of this event. A requirement needed to bring this event to Indianapolis were the sponsorships provided by Indiana's gaming companies and others. These are:

The NCPG and the ICPG recognize that the current difficult economy has made it very difficult for those working directly to help those with a gambling addiction in our region to attend the conference. If we are to build a good treatment network, these people need to attend this event. The Indiana Council has worked with the National Council to make this possible.

Each sponsorship included a great number of partial scholarships that the Indiana Council will use to assist individuals from our region who want to attend the conference. The scholarships reduce the \$450 registration fee to \$200. Of this dollar amount, \$150 will go to the NCPG and \$50 to the affiliate of the attendees home state. Scholarship attendees will receive one year memberships to each organization. This is a very unique approach to facilitating both the attendees, the NCPG and its regional affiliates. Again this was made possible by our conference sponsors and the NCPG.

# **Problem Gambling Help Line Caller Demographics**

In the first half of the current state fiscal year,7/1/08 through 12/31/08, the Indiana Problem **Gambling Help Line received a** total of 2230 calls. Of this number 659 were calls that resulted in an intake and most often a referral to a state problem gambling treatment program or a Gamblers **Anonymous or Gam-Anon support** group. These numbers are virtually unchanged from the same period last year. During this same period, 199 Hoosiers entered state funded outpatient treatment for problem gambling. ## 2009 DMHA Training events

April 29 & 30 (Phases 7 & 8)

Spirituality & recovery; Treatment design & levels of care; Relapse prevention; Workplace & EAP issues; Reimbursement strategies; Transference & counter-transference issues; Ethics standards; Resources; Certification standards

Fifteen CEUs will be awarded for completion of each two day workshop.

Joanna Franklin MS, NCGC II will again be the trainer for these sessions Deborah G. Haskins, Ph.D., will again moderate the one and one half hour clinical supervision calls. These conference calls are held twice a month for the next 12 months.

The 60 hours of training and the clinical supervision are key components needed to attain a NCGC gambling counselor credential.

#### **Gambling Recovery Ministries**

Often the topic of how awareness of problem gambling can be expanded is discussed among mental health caregivers working in this specialized field. Needed is an overall coverage of information to the public. Since I spoke to a class of social work majors at St. Benedict College in 2005, I have encouraged others to do likewise and spread the word of prevention and recovery in college classrooms, Gladly, I can report that Dr. Scott Hunt, a professor at Eastern Kentucky University, has invited me to do presentations in two of his classes. On February 2, I spoke to both the Gambling and Crime and the Religion and Criminal *Justice* classes.

Additionally, GRM co-presented with Dr. Curtis Barrett at the Kentucky Council on Problem Gambling's 12th Annual Educational and Awareness Conference at Lexington on January 30. The topic was Essential Knowledge for Faith-Based Counseling of Problem Gamblers.
